The School District of Denmark was awarded \$335 worth of curriculum materials by the "Program for Teaching East Asia." The "Program for Teaching East Asia" is a coordinating site for the National Consortium for Teaching about Asia (NCTA).

Kazuko Stone, Denmark High School instructor, secured the award for our school district by completing a 30-hour development seminar about teaching East Asian studies.

The donation includes excellent educational videos and teaching materials concerning the history, culture and art of China, Japan, and Korea. The materials will be located in the high school and will be available for use by all staff members of the district.

Attention: Non-Residents of the School District of Denmark

Avoiding a few non-residents from receiving this newsletter is difficult and costly. Our efforts to communicate with our resident families is important.

PUPIL RECORDS

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that the School District of Denmark, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, the School District of Denmark may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the School District of Denmark to include this type of information from your child's education records in certain school publications. Examples include:

A playbill showing your student's role in a drama production;

The annual yearbook;

Honor roll and other recognition lists;

Graduation programs; and

Sports activity sheets, such as for wrestling, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the *Elementary and Secondary Education Act of 1965* (ESEA) to provide military recruiters, upon request, with three directory information categories – names, addresses and telephone listings – unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent. (These laws are: Section 9528 of the ESEA (20 U.S.C. 7908) as amended by the *No Child Left Behind Act of 2001* (P.L. 107-110), the education bill, and 10 U.S. C. 503, as amended by section 544, the *National Defense Authorization Act for Fiscal Year 2002* (P.L. 107-107), the legislation that provides funding for the Nation's armed forces.)

If you do not want the School District of Denmark to disclose directory information from your child's education records without your prior written consent, you must notify the District in writing by December 31, 2008. The School District of Denmark has designated the following information as directory information:

The student's name

The student's address

The student's telephone listing

The student's date and place of birth

The student's major field of study

The student's participation in officially recognized activities and sports.

The student's weight and height if a member of an athletic team

The student's dates of attendance

The student's photograph

The student's degrees and awards

The name of the school most recently previously attended by the student

SCHOOL DISTRICT REPORT CARD: WINSS ON THE WEB

The Wisconsin Department of Public Instruction (DPI) has developed a website entitled "Wisconsin's Information Network for Successful Schools (WINSS)" to assist parents, community members, and educators learn more about Wisconsin school districts. The WINSS Successful School Guide is accessible on the web at www.dpi.state.wi.us/sig/index.html and includes detailed information on student achievement, student adequate yearly progress, student graduation rates, schools identified as in need of improvement, and professional qualifications of teachers.

STUDENT SURVEYS

As a school district receiving funds under U. S. Department of Education programs, the School District of Denmark must notify parents of their right to inspect certain student surveys and to opt their children out of those surveys and other activities that collect, disclose, or use personal information from students, including materials designed to sell or market student information to others. The types of surveys include those created by third parties (outside of the school district) and their subject matter as specified below. Parents must be notified of their rights before the survey is distributed to students.

Schools must involve parents in establishing policies that annually notify parents of this right at the beginning of each school year and when substantive changes are made to related school policies. The notice to parents must state the specific or approximate dates during the school year when activities are scheduled.

If a survey asks students for information in any of the following eight categories, schools must give parents the right to inspect the survey:

Political affiliations or beliefs of students or their family.

Mental and psychological problems of students or their family.

Sex behavior or attitudes.

Illegal, anti-social, self-incriminating, or demeaning behavior.

Critical appraisals of individuals with whom students have close family relationships.

Legally recognized privileged or analogous relationships, such as those with lawyers, physicians, and ministers.

Religious practices, affiliations, or beliefs of students or their parents.

Income (other than that required by law to determine eligibility for program participation or financial assistance).

The School District of Denmark will provide the survey to parents within a reasonable amount of time after the request and before surveys are distributed to students. The School District of Denmark will also involve parents in developing and adopting policies that establish the right of parents, upon request, to inspect student surveys and opt their children out of a survey.

ESEA TEACHER QUALITY NOTIFICATION

The School District of Denmark is committed to hiring and retaining high quality educational staff members. All teachers in our school district have at least a Bachelor's degree from an accredited college and are licensed by the State of Wisconsin, Department of Public Instruction (DPI).

The Elementary and Secondary Education Act (ESEA), also known as the No Child Left Behind Act, requires school districts to notify parents of their right to request the following information about the qualifications of the school district teachers and paraprofessionals who are educating their children.

Is my child's teacher licensed to teach the grades or subjects assigned?

Has the state waived any requirements for my child's teacher?

What was the college major of my child's teacher?

What degrees does my child's teacher hold?

Are there paraprofessionals working with my child? If so, what are their qualifications?

HOMELESS CHILDREN

The McKinney-Vento Act defines homeless children and youth (twenty-one years of age and younger) as:

- Children and youth who lack a fixed, regular, and adequate nighttime residence, and includes children and youth who are:
 - -sharing the housing of others persons due to loss of housing, economic hardship, or a similar reason (sometimes referred to as double-up);
 - -living in motels, hotels, trailer parks, or camping grounds due to lack of alternative adequate accommodations;
 - -living in emergency or transitional shelters;
 - -abandoned in hospitals; or
 - -awaiting foster care placement.
- Children and youth who have a primary nighttime residence that is a public or private place not designated for, or ordinarily used as, a regular sleeping accommodation for human beings.
- Children and youth who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings.
- Migratory children who qualify as homeless because they are living in circumstances described above. If you are personally aware of or are acquainted with any children who may qualify according to the above criteria, the School District of Denmark provides the following assurances to parents of homeless children:
 - The local district staff person (liaison) for homeless children is the Director of Pupil Services.
 - There shall be immediate enrollment and school participation, even if educational and medical records and proof of residency are not available.
 - All educational opportunities and related opportunities for homeless students (preschool to age 21), including unaccompanied youth, shall be the same as for the general student population.
 - Enrollment and transportation rights, including transportation to the school of origin ,shall be possible. "School of origin" is defined as the school the child attended when permanently housed or when last enrolled.
 - Written explanation of why a homeless child is placed other than in a school of origin or school requested by the parent, with the right to appeal within the local dispute resolution process.
 - Meaningful opportunities for parents to participate in the education of their children. These shall include: special notices of events, parent-teacher conferences, newsletters, and access to student records.

SPECIAL EDUCATION REFERRAL AND EVALUATION PROCEDURES

Upon request, the **School District of Denmark** is required to evaluate a child for eligibility for special education services. A request for evaluation is known as a referral. When the district receives a referral, the district will appoint an Individualized Education Program (IEP) team to determine if the child has a disability, and if the child needs special education services. The district locates, identifies, and evaluates all children with disabilities who are enrolled by their parents in private (including religious) schools, elementary schools and secondary schools located in the school district.

A physician, nurse, psychologist, social worker, or administrator of a social agency who reasonably believes a child brought to him or her for services is a child with a disability has a legal duty to refer the child, including a homeless child, to the school district in which the child resides. Before referring the child, the person making the referral must inform the child's parent that the referral will be made.

Others, including parents, who reasonably believe a child is a child with a disability, may also refer the child, including a homeless child, to the school district in which the child resides.

Referrals must be in writing and include the reason why the person believes the child is a child with a disability. - The veterans of the community were again treated to an outstanding program held at the middle school in November.
- By all accounts, the high school musical "Oliver" was a huge success based on student performances and attendance at the programs.
- There was a great learning experience this fall among DHS students, the Denmark Technical Education Department, NWTC students, NWTC resources, and the support of local businesses including Bielinski Excavating. The teaching of brick laying and concrete work culminated with a concrete pour in back of the storage garage.
- The elementary school, with help from a grant from Dean's Distributing, will be providing afterschool reading help to second graders starting this month. This is a continual effort to help all students become proficient in reading, as that is a very strong indicator of future student success.
- There have been a number of wonderful music programs that have already occurred this school year. However, with the holiday season upon us, there are many opportunities to watch our talented students perform in the next few weeks.
- Day-to-day there is a district full of dedicated staff helping students achieve their best to help prepare them for the future.

With all of the good news occurring in the district, there is also deep sadness. The School District of Denmark lost a superb educator and human being with the passing of Diane Thomas who lost her battle with cancer on November 4. Diane was a wonderful teacher and helped many, many students learn the love of reading and writing. Her legacy will live for many generations. Our thoughts and prayers are with her husband, Doug, along with their children and their spouses.
