INVESTING HONORS

While many have watched their 401k accounts struggle, some Denmark High School students found investment gems in a difficult market. Denmark High School Investing 101 students competed against other State of Wisconsin schools in the Fall 2008 Stock Market Competition sponsored by Economics Wisconsin. Students invest \$100,000 in stocks, bonds, or mutual funds over a fifteen week period. Through the experience, students learn about financial markets and institutions, supply and demand in real markets, current events surrounding the economy, and key economic events of history.

Teams are evaluated on how their portfolios perform against the S&P 500 during the same time frame. Denmark placed two teams in the top five in the State of Wisconsin. This is the best showing Denmark Investing 101 students have ever made in this competition. Economics Wisconsin recognizes the top teams in each region with a small banquet at the Apple Creek Inn in De Pere, Wisconsin.



The students on the left, Amanda Wyngaard, Lucas Klarkowski, Brandon Havlovitz and Pat Landt took fourth place. Brandon Conard, Joe Pavlovich, Jade Laundrie, Tony Poplin, and Brent Larsen, on the right, took first place in the competition.

GRANTS AWARDED

The Department of Public Instruction (DPI) recently awarded student mini-grants. Awards are based on recommendations by the CESA partnership council that are then reviewed by DPI Staff. The School District of Denmark has been award two of the mini-grants. Mark Meisner, teacher at the Denmark Empowerment Charter School, received \$1,000. Cindy Grueneberg, Guidance Counselor, and the "Bully Blockers: Here to Help" group at Denmark Elementary also received \$1,000. The groups will work with CESA's Wisconsin Alcohol, Tobacco, and Other Drug Education Network to implement their programs.

STUDENT RECOGNITION

Alisha Honkanen, a student at the Denmark Empowerment Charter School (DECS), had the honor of a letter she wrote being published on the National Alliance for Public Charter Schools website (www.publiccharters.org). Alisha's story explains how she has changed through her experiences at DECS. The Alliance is a national nonprofit organization committed to advancing the charter school movement. The Alliance works to increase the number of high performing charter school available to all families, particularly lowincome and minority families who currently do not have access to quality public schools.

School District of Denmark Becoming More Green

Every business is attempting to become more energy efficient in the wake of the high cost of energy and the negative impact burning of greenhouse gases has on our environment. The School District of Denmark is no different. Below is a partial list of recent changes completed to allow more of the district budget to be spent on items that directly improve student learning and also to lessen our carbon footprint on the environment.

Replaced Lights in the High School Gymnasium

The total material and labor cost of replacing the high school gym lights was \$17,316. "Focus on Energy" provided a grant of \$4,560 for this project, so the net cost to the district was \$12,756. Because of the decrease in wattage used, the annual savings will be \$3,685. The payback for replacement of the lights will be less than four years. The lights have two settings. For everyday use the level is 50 foot candles and for events and competitions the lights are set at 70 foot candles. People who have visited the gym since the replacements have noticed a definite improvement in the lighting. The old lights and fixtures are either being recycled or kept to be used as replacements at other buildings.

Additional High School Boiler

Originally, the Denmark School Board approved the additional boiler (two million BTUs) to be used for off-peak times, mainly in the fall and spring of each year. The old boilers were extremely ineffective for these off-peak times. However, the system is presently being tested to run the high school heating system full time. This would save the district even more money than was planned. The total cost of the boiler project was \$54,828. "Focus on Energy" provided a grant of \$3,776, so the net cost to the district was \$51,052. The annual savings for off-peak times was projected to be \$9,441, with payback occurring in 5.4 years. We are predicting payback will occur much earlier if we find the new boiler is able to heat the high school for most of the year.

Replacement of Windows at the Elementary School

The Elementary School windows were very energy inefficient. Cold drafts and whistling were constant problems during cold weather. Obviously, this also allowed warm air into the buildings when the system was set to cool. So far, all windows on the west side of the building have been replaced within the last two years at a cost of \$33,800. Blinds are now between the panes of each window to eliminate the cost of having to repair and replace blinds from wear and tear. The north side of the building will be completed next as funds are available.

Other energy efficiency projects completed in the last several years include:

- All hallway and classroom lighting updated at the Elementary School.
- All thermostats at the Elementary School are now controlled by DDC or Direct Digital Controls for higher efficiency.
- All district exit signs are LED.
- High School parking lot lights are now timed to go off at 11:30 PM until the morning if needed.

Future projects as funds are available are:

- New fixtures and lights in every gymnasium.
- Hot water system will be replaced shortly at the Middle School.
- Continue window replacement at the Elementary School.
