DISTRICT NEWS

One of the most difficult decisions the Denmark School Board made the past three years was setting the tax levy for the district. This year the Denmark School Board approved a tax levy of \$6,127,494 which brings the district-wide mill rate to 10.157 or \$10.16 per \$1,000 of property value. This change means an additional tax of \$69.65 for property valued at \$150,000 for the 2011-12 school year. (The increase will vary across municipalities.)

The School District of Denmark has historically been a very low spending district. According to the Wisconsin Taxpayers Alliance, the Denmark District's fund balance remained in the bottom 10% of all schools in Wisconsin, and spending-per-child in the bottom 30% for the 2010-11 school year. The previous two years, the district did not use the full authority granted by the voters because federal stimulus dollars were available to offset decreased State support. By not using full revenue authority, the savings to taxpayers the past two years was \$263.50 for \$150,000 of property value. Last year the Board refinanced long-term debt to lower the tax rate. In an attempt to match decreasing revenue allowed by the State, the School District has cut close to \$1.5 million from the budgets since the 2004-05 school year.

For the 2011-12 school year, the district has implemented a number of steps to balance the budget yet keep programs in place. To reduce the tax burden to local property owners, the Denmark School Board refinanced debt again this year. Employees are paying 50% of the Wisconsin Retirement System pension payments and additional dental and health insurance premiums. The employee-paid portion of the health insurance deductable doubled from last year. A number of teaching positions open from retirements were not filled, two aides were put on layoff, and the administrative staff was reduced by one halftime position.

While the increase in the tax levy is difficult for all, good news does exist. The Denmark School Board does not plan a referendum to exceed the revenue limit for the 2012-13 school year. The Board will attempt to balance the 2012-13 budget by continual reductions where appropriate or use the district fund balance if needed. Currently, the mill rate is projected to decrease significantly from the 2011-12 school year. We will have some clear estimates of this reduction when the district receives aid estimates from the State. After the 2012-13 school year, an additional \$386,375 will be removed from the tax roll because long-term debt payments will decline significantly.

As a result of the School District of Denmark's positive public perception, the number of students Open Enrolling into our district continues to climb. For 2011-12, 68 more students entered our district than left under open enrollment, bringing in \$475,000 of additional revenue for this fiscal year. For this reason, among others, the Denmark School Board continues to maintain and improve academic and co-curricular programs allowing our district to be attractive to families.

DENMARK NAMED RESPONSE TO INTERVENTION DEMONSTRATION SITE

Project will exemplify effectiveness of the Wisconsin RtI Framework developed by the Department of Public Instruction

Six schools have been named Response to Intervention (RtI) demonstration sites in the first year of the Wisconsin RtI demonstration sites project. Those schools are

Denmark Elementary School, School District of Denmark;

Community Elementary School, Edgerton School District; Marshall Elementary School, Marshall Public Schools; Northern Hills Elementary, School District of Onalaska; Stanley-Boyd Elementary School, Stanley-Boyd School District; Barton Elementary, West Bend Joint School District.

The Wisconsin RtI demonstration sites project joins schools with the Wisconsin RtI Center, the Wisconsin Department of Public Instruction (DPI), and the National Center on Response to Intervention (NCRtI) for the purpose of exemplifying and researching the Wisconsin RtI Framework as outlined in DPI's *Response to Intervention in Wisconsin Guiding Document* (http://www.wisconsinrticenter.org/assets/files/rti-guiding-doc.pdf).

In an extensive application process, these schools showed strength throughout the 17 criteria, such as: a commitment to the RtI principle that every child can learn; involvement and commitment from the school and district leadership to RtI; an infrastructure that can support a quality RtI system through appropriate scheduling, staffing, etc.; use of teaching tools that have been proven through research to be effective; and the systematic use of data by the entire staff in making educational decisions. In addition, the six schools were carefully chosen to represent a cross section of the state, such as geographical location, size of school and community, and cultural diversity of the students.

"Over the past years, these demonstration schools have worked diligently to create an effective multi-level system of support for their students. Participating in this partnership demonstrates their continued dedication to refining and improving their system of support," said Heidi Thuli, academic coordinator of the Wisconsin RtI Center.

The Wisconsin RtI Center will guide these chosen demonstration sites, which are already implementing RtI with quality and fidelity, in expanding their process to be in line with the Wisconsin RtI Framework.

The first year of the project includes schools focusing their current RtI efforts on reading at the elementary level. Data will be formally collected to assist in documenting the schools' journeys and their outcomes.

For the schools, this partnership will recognize, improve, and refine their current RtI implementation with the assistance and resources of the Wisconsin RtI Center and via partnership with the other demonstration schools.

This project will also provide a concise consistent "Wisconsin RtI Implementation Story" for other schools in the state including


- a description of each level of reading support regarding instructional resources and practices, collaborative structures, and balanced assessment tools and processes; and
- outcomes of RtI implementation on student data, system structures, and staff climate.

Schools and school districts nationally have been embracing RtI as a data-driven process to help students achieve high levels of academic and behavior success. In the Wisconsin RtI Framework, the emphasis is placed on high quality instruction, collaboration, and balanced assessment, with the awareness that all of these need to be enacted with culturally responsive practices. Interventions are administered at varying levels of intensity in a multi-level system of support as determined by student needs.

"We believe the Wisconsin RtI Framework makes a difference in schools choosing to implement. This project gives us an opportunity to showcase that difference and celebrate the success of these six schools," said Thuli.

ANNUAL NOTICES

ASBESTOS NOTIFICATION

As a result of recent federal legislation (Asbestos Hazard Emergency Response Act—AHERA), each primary and secondary school in the nation is required to complete a stringent inspection for asbestos and to develop a plan of management for all asbestos containing building materials. The School District of Denmark has a goal to be in full compliance with this law and is following the spirit, as well as the letter of the law. As a matter of policy, the district shall continue to maintain a safe and healthful environment for out community's youth and employees.

In keeping with this legislation, all buildings (including portables and support buildings) owned or leased by the School District of Denmark were inspected by EPA accredited inspectors and samples were analyzed by an independent laboratory. Based on the inspection, the school prepared, and the state approved, a comprehensive management plan for handling the asbestos located within its buildings safely and responsibly.

Furthermore, the School District of Denmark has completed their 3-Yer Re-inspection required by AHERA. Our district buildings, where asbestos containing building materials:

*Continued our Operations and Maintenance Program

Federal law requires a periodic walk-through (called "surveillance") every six months of each area containing asbestos. In addition, the law requires all buildings to be re-inspected every three years after a management plan went into effect. MacNeil Environmental, Inc. will accomplish this under contract.

Short=term workers (outside contractors—i.e., telephone repair workers, electricians and exterminators) must be provided information regarding the location of asbestos in which they may come into contact. All short-term workers shall contact the district's Designated Person before commending work to be given this information.

The School District of Denmark has a list of the location(s) and type(s) of asbestos containing materials found in that school building and a description and time-table for their proper management. A copy of the Asbestos Management Plan is available for review in the school office. Copies are available at 25 cents per page. Questions related to the plan should be directed to the School District of Denmark at 920-863-4000.

PUBLIC NOTICE OF PUPIL NONDISCRIMINATION

It is the policy of the School District of Denmark that no pupil may be denied admission to any public school in this district, be denied participation in, benefits of, or be discriminated against in any school district curricular, extracurricular, pupil service, recreational, or other program or activity because of the pupil's sex, race, religion, national origin, color, ancestry, creed, pregnancy, marital or parental status, sexual orientation, physical, mental, emotional or learning disability or handicap, or homeless student status as defined by Sec. 118.13, Wis. Stat. This policy also prohibits discrimination as defined by Title IX of the Educational Amendments of 1972 (sex), Title VI of the Civil Rights Act of 1964 (race and national origin), Section 504 of the Rehabilitation Act of 1973 (handicap), and the McKinney-Vento Homeless Education Assistance Act. The District encourages informal resolution of complaints under this policy. A formal complaint resolution procedure is also available.
